Sir,

First of all on behalf of AIGETOA, UP(East) Circle, I would like to extend my hearty thanks to your good self for attending the Annual Circle Conference organized by AIGETOA, UP(East) Circle during its Annual Circle Meet on 12<sup>th</sup> May 2007 at Lucknow. Your kind presence boosted the moral of not only the GEJTO's who were present in the conference, rather all the GEJTO's of UP(East) Telecom Circle. The Annual Circle Meet was concluded with the following resolutions regarding betterment of BSNL at large.

1. The capabilities of GEJTO's should be employed in core technology areas. In addition GEJTO's can be trained for both technological and managerial skill in order to make BSNL to cope up with the challenge of being equipped with human resource updated with every minute change in telecom technology & trends and to make a stand in this competitive era.
2. As it is a known fact that telecom technology is changing every day and that India is the second largest market in telecom sector, it is imperative to be updated with the ongoing and futuristic vision of technology trends. This can be realized only when we get to know the international standards and technologies. So, provision must be made to impart foreign training and company oriented training to the GE-JTOs. Such initiation will make BSNL services front manned with a confident personnel who is capable of handling NT switches and the like with dexterity.
3. The better marketing strategies to position the mobile services, broadband services can be adopted to attract the various segments of customers. The benchmark for the quality should be fixed and be continuously monitored for delivering better services to our valued customers.
4. The BSNL should take appropriate steps to adopt Corporate Culture in the organization.

5. The BSNL must take appropriate steps to extend every information regarding its various plans in respect of its services to its employees so as to make the vision "Each Employee Salesmanship" talked about by your good self, a realization.
6. The GE-JTO's were in agreement with your views regarding special attention in information technology in BSNL. In this aspect this is to say that, on contrary to the fact that under the brand name BSNL we claim to be the country's largest telecom service provider, we still have a long path to cover regarding IT penetration within the organization and most important, making it evident in our work culture. This requires, the management of BSNL to realize in spirit the need of developing a well-informed BSNL employee irrespective of his/ her cadre.
7. The order of confirmation should be issued to all the GEJTO's who have completed two years of service in BSNL.
8. The Employee Provident Fund (EPF) issue is still unsolved. No annual EPF statements have been provided to the GEJTO's. Also, no standard deduction has been made from the date of appointment. Necessary orders should be issued to resolve the EPF issue within a time frame.
9. The roster for SC/ST quota should be implemented effectively for officiating promotions so that the GE-JTO's are not deprived off from promotions.
10. Necessary arrangement must be done regarding refund of security to the GE-JTO's deposited by them at the time of joining services in BSNL.

In the same meeting, we have elected a new Circle Executive Committee as per detail enclosed herewith. I request your honour to kindly recognize our above stated body. I would like to assure best cooperation and support for the betterment of our beloved organization, BSNL. Also, I hereby request your honour to allow us to meet your goodself in person to have a detailed discussion on the resolutions and issues of GE-JTO's cited above.
